



## **Our Governors**

At Halesowen CE, our Governing Body is involved in ensuring that we provide the best education possible for the children in a safe, happy and secure environment.

Being a church school the majority of our Governors are appointed by the Diocese and have strong links to St John's the Baptist Church. We also have provision for 2 Parent Governors, Staff Governors including the Head teacher and a Local Authority Governor.

### **The Responsibility of our Governing Body:**

- Monitor the performance and progress the school is making.
- Work with staff to ensure children reach their full potential.
- Oversee the school's policies and procedures. They are held under review and are updated and amended in accordance with new legislation, government requirements and the needs of the school to run effectively and successfully.
- Be a source of challenge and support to the Head teacher.
- Gain feedback from the school, including parents, pupils and staff.
- Be regularly seen in school at events and during parent evenings.

Governors meet as a whole Governing Body 3 times a year. We also have a Resources Committee and a School Improvement and Christian Distinctiveness Committee that meet 3 times a year. The statutory committees are also in place for Staff Dismissal, Pupil Discipline and Appeals.

All our Governors are expected to attend training courses to ensure their knowledge is kept up-to-date. They also attend some of our inset days and staff meetings to keep up with developments within the school and to give feedback/input where required.
